6 **ARTICLE 17. ASSIGNED TIME**

7 17.1 For the 2017-18 and 2018-19 academic years, there will be six (6) unit members
8 appointed to the Academic Senate. Subsequently, the number will alternate between five
9 representatives and six representatives, in two-year blocks of time. Each unit member appointed
10 to serve on the Academic Senate shall receive a stipend in an amount equal to ~~84~~ 60 hours
11 ~~hours, paid at the unit member's respective hourly rate of compensation~~ per academic year,
12 exclusive of intersession terms, ~~paid at the corresponding non-classroom non-contractual hourly~~
13 ~~rate of compensation from Exhibit A.~~

14 17.1.2 ~~In the event a unit member is elected to be an officer of the Academic Senate, they~~
15 ~~will be paid 32 hours, paid at the unit member's respective hourly rate of compensation, for each~~
16 ~~month the Senate meets.~~

17 17.2 There will be five (5) unit members appointed by the Academic Senate to serve as
18 voting members on up to six (6) standing collegial governance committees at the District. Unit
19 members appointed by the Academic Senate to serve on collegial governance committees shall
20 receive stipends in an amount equal to 24 hours per academic year, exclusive of intersession
21 terms, ~~paid at the corresponding unit member's respective hourly rate of compensation-non-~~
22 ~~classroom non-contractual hourly rate of compensation from Exhibit A.~~

23 17.3 Unit members may accept non-teaching assignments approved by the District
24 including, but not limited to, administrative, coordinative, governance, project specific, or other
25 activities determined to be beneficial to the District. In the event the assignment is primarily
26 related to instruction, the assignment will be counted as part of the maximum assignments
27 permissible under section 7.1.1 of this agreement. Any such assignments are voluntary on the
28 part of the unit member. A decision by a unit member to decline a non-teaching assignment shall
29 not be considered in the assignment of classes or in future non-teaching opportunities.

30 All non-teaching assignments shall be compensated at half (1/2) of the corresponding
31 classroom or non-classroom hourly rate of compensation from Exhibit A. The amount of hours
32 assigned shall be designated by the appropriate District administrator at the time of the
33 assignment.
